The Irwin County Board of Commissioners had its monthly meeting on September 06, 2022. The meeting was held at the Courthouse Annex; at the meeting were Chairman Scott Carver, Commissioner Aldene Tyson, Commissioner Jimmy Mobley, Commissioner Chris Paulk, Lynn Hall, Marc Mathis, Don Hickey, Red Cross Staff and County Clerk Patricia Battle.
